REDUCED PRESSURE

- Greater occipital pressure distribution reduces the risk of pressure injuries (never events)
- 20° cervical lordosis built into posterior panel provides anatomically correct patient positioning, increased immobilization and reduced pressure for supine patients

INCREASED STABILITY

- Larger posterior panel stabilizes the C-Spine by capturing a greater area above the occiput resulting in increased stability and immobilization
- Restricts cervical motion during anterior displacement test case study *

- Universal Sizing with 60 micro-adjustment settings captures a greater patient population including short and stout necks
